ARTICLE 1. NAME, OBJECTS, ORGANIZATION AND JURISDICTION.

Section 1. Name.

The name of this organization is The Cabrillo Chapter, The American Institute of Architects.

In these bylaws the above named Chapter is referred to as "this Chapter"; the governing board of this Chapter as the "Executive Committee"; the State Organization of Architects as the "California Council"; The American Institute of Architects as The Institute; and The Board of Directors of The Institute as "The Institute Board."

Section 2. Objects.

The objects of this Chapter shall be to promote and forward the objects of the American Institute of Architects within the territory of this Chapter.

Section 3. Organization.

This Chapter is a nonprofit membership corporation association duly incorporated on the 11th day of August, 1966, under and by virtue of the provisions of General non-Profit Corporation law of the State of California, and a successor to the Cabrillo District of the Southern California Chapter, The American Institute of Architects, an unincorporated association chartered by The Institute on the 1st day of January, 1959.

Section 4. Territory.

The territory within which this Chapter shall represent and act for The Institute is that described in its charter or otherwise prescribed by The Institute, and as defined by Map "A" Appendix.

Section 5. Governing Board.

The affairs of this Chapter shall be conducted by a governing board called the Executive Committee.

Section 6. California Council.

- (a) This Chapter shall have representation in the California Council in the manner provided for in the Council bylaws.
